Transaction Criteria

- EBITDA: \$5 - \$15M
- Heritage Equity Target: \$10 - \$20M
- Continuing owner-manager retained ownership (> 30%)
- Conservative leverage to preserve flexibility and support growth

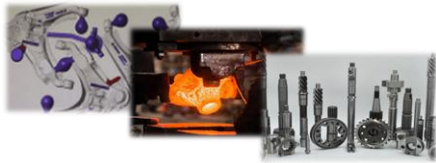

Realization

Over a 6-year investment, Heritage Growth worked alongside management to increase sales from \$70M to \$500M+ through strong organic growth and 8 add-on acquisitions. Heritage exited its ownership through a majority recapitalization of the business
